PLEASE READ THIS SECTION CAREFULLY

I understand that skiing and snowboarding are HAZARDOUS activities. I understand that skiing and snowboarding, including jumping, or use of terrain parks include inherent man made and other risks of injury or death that reasonable care, instruction and expertise cannot eliminate. I also understand that injuries are common and ordinary occurrences during these activities. I hereby agree to freely, voluntarily and expressly ASSUME and accept ALL RISKS of death and any injury to any part of the users body while skiing or snowboarding.

I understand that the Alpine ski equipment being furnished forms a part or all of a system which will NOT RELEASE OR RETAIN at all times or under all circumstances. I further agree and understand that this ski-boot-binding system does NOT ELIMINATE THE RISK of any injuries to any part of this user's body, including the knee. If Snowboard equipment is being furnished, I understand these systems are designed to NOT RELEASE at any time and that their use does NOT PROTECT AGAINST OR REDUCE THE RISK of any injuries to any part of the users body, including the wrist, knee, or ankle.

I agree to forever release this ski/snowboard shop and all equipment distributors and manufacturer's (collectively called "suppliers") from, and indemnify them (defend and hold suppliers harmless for any fees, costs, settlements, and or verdicts that result from any claims or lawsuits relating to the use of this equipment) for, any and all liability and responsibility for any injuries or damages to the user of any of this equipment even if such injuries and damages are caused by the suppliers' NEGLIGENCE. I accept full personal liability and responsibility for any and all such injuries and damages. This ski/snowboard shop, itself, provides NO WARRANTIES, express or implied and this equipment is accepted "AS IS."

I have carefully read this ASSUMPTION OF RISK- WARNINGS, RELEASE OF LIABILITY AND INDEMNITY AGREEMENT and fully understand its contents.

I am aware that this is a binding contract. However, it is not intended to assert any rights or defenses that are prohibited by law. The specific legal rights of the parties may vary from state to state. I agree that if any provision of this and release of liability is determined to be illegal or unenforceable for any reason, the same shall be severed and the remainder of this contract shall be given full force and effect. I have also read Section 3 of this form and will be responsible for obtaining all the information referred to in that section and providing it to the user of this equipment.

By signing this document I know I am waiving certain legal rights which I or my family, relatives, legal, representative may have against suppliers, including the right to sue.

Parent/Guardian: I verify that I am the parent/guardian of this minor and this minor has my permission to participate in this sport. I have the authority to enter this agreement on behalf of this minor. I agree on behalf of myself and the other parent/guardian to the terms of this agreement including the indemnification and the holding harmless of this shop and Section 3.
